In consideration of accepting registration and permitting the voluntary participation of the above named participant in the FUTSOC program, for myself and on behalf of the participant, our heirs, assigns and next of kin, I hereby release, discharge and agree to hold harmless, the County of Broward, the City of Weston, Tequesta Trace Park / Heron Park (our primary training fields) or any other park utilized by us for practice, scrimmage or game purposes, FUTSOC, Jose Tamayo – Technical Director / Coach, and any of its other assistant coaches, counselors, representatives, volunteers and sponsors from any and all claims, demands, costs, expenses and compensation arising out of or in any way related to any physical injury or other damage that may result to said participant, while participating in any part of the Program, including any physical or other injury caused by negligence of any such person while performing their duties at any time.
